BAC 4 MEMBERS SAFETY TRAINING REQUEST FORM INSTRUCTIONS

- 1. You must be a BAC Local 4 member in good standing.
- 2. Fill out the Online Safety Training Request Form completely. Forms can be found on our apprenticeship website: bac4training.org
- 3. You must provide an accurate and working email address.
- 4. The Apprenticeship office will send you an email confirmation. Please check your spam folder. You must respond to the email to confirm you have a valid email address.
- 5. After your email is confirmed; you will receive an email with instructions and a link to the training website. Your username will be your email address and the pass word is your 6 digit I.U. number.
- 6. After completion; send your "Certificate of Completion" to the Apprenticeship Office. You must do this to receive a Stipend.
- 7. After your Certificate is received by the Apprenticeship office. Your completion will be documented with the Local 4 office and the Apprenticeship office.
- 8. The Union Hall will request a reimbursement checks from the trust fund. Checks will be mailed to your address given on the request form.
- 9. When your completed request form is received by this office and your membership is confirmed, you will received an email confirmation with a link or links to the only OSHA 10/30 training site for which will be accepted for reimbursement.
- 10. The reimbursement amount is \$39.00 for OSHA 10 and \$189.00 for OSHA 30. Reimbursements are limited to 1 per calendar year.
